

MMCP Guidance - Metrc Lab Test Batches

The Medical Marijuana Control Program (MMCP), pursuant to authority in Ohio Revised Code/Ohio Administrative Code 3796, is providing guidance on the use of the Metrc Lab Test Batches. Effective **March 28, 2022,** licensees will be required to use **revised, standardized** Lab Test Batches when submitting medical marijuana for laboratory testing in Metrc.

Ohio Administrative Code 3796 establishes testing analysis requirements and acceptable thresholds. Currently, when submitting medical marijuana for laboratory testing in Metrc, licensees must choose Lab Test Batches by category (e.g. pesticide, heavy metal, etc.). The MMCP is reconfiguring Metrc Lab Test Batches to allow licensees to simply select the appropriate stage of production, which will include all of the required testing for each stage.

Implementation of standardized Lab Test Batches will streamline the process to ensure that all medical marijuana has been submitted to and met the requisite threshold requirements as mandated under Ohio Administrative Code 3796, prior to distribution to patients at dispensaries. Furthermore, this guidance will allow for more efficient business practices for licensees and ensure all requisite testing is completed.

The MMCP will be monitoring Metrc to ensure licensees comply with this guidance. Failure to utilize the appropriate Lab Test Batch may result in retesting, administrative hold, destruction of product, and/or further action by the Department. Available Metrc Lab Test Batches

Licensees shall use the Lab Test Batches for mandated laboratory testing. Lab Test Batches will no longer be organized by category (e.g. pesticide, heavy metal, etc.). Individual tests per Lab Test Batch can be found in the attached **Appendix A** to this guidance.

Lab Test Batch Selection Guide

The following tables are divided into three categories: (1) Plant Material; (2) Marijuana Derived Ingredients; and (3) Manufactured Product, that outline the required Lab Test Batch mandated dependent upon the medical marijuana's form and destination. As such, licensees should refer to this selection guide when adopting this guidance and ensure that they are using the MMCP's standardized Lab Test Batch when inputting the data into Metrc.

When conducting retesting, licensee must choose the category of analyte associated with the particular failure (e.g. if medical marijuana fails for lead, licensee would be required to retest for all heavy metals). All tests associated with a Lab Test Batch must be completed and accurately reported into Metrc.

Ohio Statutory and Administrative Authority

- Ohio Revised Code 3796.03(C): permits the Department to establish any rules it deems necessary for the ongoing administration of the medical marijuana control program.
- Ohio Administrative Code 3796:5-6-01 and 5-6-02 permit the Department to enforce the rules and regulations established under Chapter 3796 of the Ohio Administrative Code.
- Ohio Administrative Code 3796:2-2-01 and 3-2-01 mandate that licensees establish and maintain certain policies and procedures within their standard operating procedure that ensure compliance with the rules for production, storage, inventory, and transportation of medical marijuana.
- Ohio Administrative Code 3796:2-2-04 and 3-2-04 mandate that licensees track and submit into the METRC system any information the Department determines necessary for maintaining and tracking medical marijuana.
- Ohio Administrative Code 3796:2-2-06 Cultivator lab testing
- Ohio Administrative Code 3796:3-2-06 Processor lab testing
- Ohio Administrative Code 3796:4-2-04 Lab testing requirements
