** Diamond Science, LLC and PalliaTech Ohio, LLC each had two applications that qualified for licensure. They will each be required to choose a single location for their respective licenses. On January 15, Diamond Science selected its Dayton location.

*** Ohio Craft Cultivators, LLC and Silphium Extracts, LLC did not submit clarification responses. They were disqualified based on their Round 1 scores.
